1. RESEARCH

2. TEACHER WORKLOAD

Teachers have a huge amount of work each week and can only do so much. Their time needs to be carefully prioritised on activities of the greatest benefit to children. Detailed marking of homework, which often not all children have completed, and the tasks of checking who has completed what (even online) is a significant amount of work each week. Work which the research is telling us is of dubious benefit.

3. THE LAW

The law states that primary schools in England must set homework. However, unlike secondary schools, we are not allowed to discipline children who do not

complete it. This may be why the research shows that homework in secondary schools does benefit children.

4. OFSTED

In 2019 Ofsted removed the inspection of homework from their framework. OFSTED’s framework is research led and this omission from their schedule may reflect the lack of evidence showing homework’s effectiveness. Like teachers OFSTED inspectors must use their time effectively.

5. TRANSITION

Children moving into year 7 can be shocked by the amount of homework they receive in secondary school. Detentions are issued to children who do not hand in work following a warning. Therefore, Year 6 children need to be prepared for this additional burden and to be familiar with the quantity of additional work they will be required to do at home. To maximise the progress our children make the table below sets out our targets for each year group to perform at home:-
